Propane (LP) Gas Agreement for New Customer

- All new applicants must complete a credit application before any service is provided. The application will be checked with a credit bureau and New Dixie Oil Corporation reserves the right to grant or deny the applicants secure credit. In some cases New Dixie Oil Corporation may ask for a co-signer or a security deposit to help
- New Dixie Oil Corporation will need to know the following information to provide safe propane service to the residence or building.
 - Is there service to the property now? If so what size tank is provided? Is this rental property? Most of these questions can be answered on the application.
 - At installation and any time the tank runs out there will be a service charge for a safety inspection which includes appliances, lines, regulator and a pressure test of the system. Our responsibility includes the tank (if owned by us) and piping thru 1" stage, or twin stage regulator. The customer is responsible for line or lines leaving such regulator, to all runs of piping and appliances. In the event there is a leak, and it is determined it is New Dixie's responsibility, there will be no charge, and if it's the customer's responsibility they will be charged. New Dixie Oil Corporation warrants piping installed, for a period of 90 days, in regards to materials or workmanship.
 - Special trips and pressure tests will be COD, NO MORE CHARGING ONTO THE ACCOUNT. Must be paid in office first.
 - All accounts are payable by next delivery date or must pay plan and no later than the 15th of the following month. Finance charges will accrue after 30 days.
 - If New Dixie Oil Corporation request a security deposit, that money will be held in a separate account until such time the equipment is picked up and the account is in good standing.
